**ESSENTIAL NATIONAL VIDEO SALE ENTRY CONDITIONS**

1. All NAIT compliance is the responsibility of the vendor.
2. Theileria Tick management – see National Video Sale Entry Conditions.
3. All cattle must be TB tested and cleared within 12 months of the date of sale, with the exception of cattle from a movement control area which must have been tested and cleared within 60 days of the sale. TB test certificates must be lodged with the breed association, no later than the Friday prior to National Video Sale. This rule will be enforced without exception.
4. All cattle must have been tested BVD Antigen negative and have been vaccinated twice within the last 12 months. The vendor must declare this in writing, accompanied by the vaccine batch number administered, with the breed society/association, no later than the Friday prior to the PGG Wrightson Livestock National Video Sale..
5. Ear Tagging – all entries must display the mandatory NAIT/EID Breed tag requirements..
6. No refunds will be issued after the 23rd March 2018 due to catalogue requirements.
7. A proof of entry will be emailed for review as it will appear in the PGG Wrightshon Livestock National Video Sale catalogue.
8. All animals must have a DNA profile on file
9. All entries must be inspected by a senior judge and stock agent prior to going to the National Video Sale.
10. All entries must have 3 EBV's/indexes above the breed average.
11. Video to be filmed by technician approved by the NZ Shorthorn Association & all at the vendor's cost.

I have sighted the bull entered and verify that he is a worthy representative of the breed and at the National Video Sale it will be a credit to both the vendor and the Shorthorn breed.
